The Local Government Unit of Talacogon, Agusan del Sur, through the Provincial Government of Agusan del Sur, had received the sum of ONE MILLION PESOS (Php 1,000,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Concreting of Del Monte Evacuation Center Access Road (BAC-LGU-TADS-2024-02). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Local Government Unit of Talacogon, Agusan del Sur now invites bids for the Concreting of Del Monte Evacuation Center Access Road. Completion of Works is required within a contract duration of 45 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through an open competitive bidding procedure using a non-discretionary "Pass/Fail" criterion as specified in 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino Citizens/Sole Proprietorship, Cooperatives, and Partnerships or Organizations with at least Seventy-Five Percent (75%) interest or

outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Local Government Unit of Talacogon through the BAC Secretariat Office and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested bidders from January 26, 2024 to February 15, 2024, from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (Php 1,000.00).

The LGU of Talacogon, through the BAC will hold a Pre-Bid Conference at 2:00 p.m. February 2, 2024, at the MSWD Office of LGU, Talacogon, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before February 15, 2024, 2:00 p.m., All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bid Opening shall be at 2:00 p.m. on February 15, 2023, at the Municipal Social Development Office, Municipal, Talacogon, Agusan del Sur. Bids will be opened in the presence of the Bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.

The LGU of Talacogon through the BAC reserves the right to reject any and all bids, declare a failure of bidding, or not to award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 at its IRR, without thereby incurring any liability to the affected bidder or bidders.
