The Local Government Unit of Talacogon, Agusan del Sur, through the Trust Fund FY 2025 downloaded from Bureau of Fisheries and Aquatic Resources had allocated the sum of Thirty One Million, Two Hundred Sixty-Nine Thousand, Nine Hundred Seventy-Nine Pesos (Php 31,269,979.00) being the Approved Budget for the Contract (ABC) contract for the ESTABLISHMENT OF MULTI-SPECIES HATCHERY IN THE MUNICIPALITY OF TALACOGON, AGUSAN DEL SUR (RA 12074) with Reference Number (BAC-LGU-TADS-2025-17). Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Local Government Unit of Talacogon, Agusan del Sur, now invites bids for the ESTABLISHMENT OF MULTI-SPECIES HATCHERY IN THE MUNICIPALITY OF TALACOGON, AGUSAN DEL SUR (RA 12074). Completion of Works is required within a contract duration of 400 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instruction to Bidders.

Bidding will be conducted through an open competitive bidding procedure using a non-discretionary "Pass/Fail" criterion as specified in 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184),

otherwise known as the "Government Procurement Reform Act." Bidding is restricted to Filipino Citizens/Sole Proprietorship, Cooperatives, and Partnerships or Organizations with at least Seventy-Five Percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Local Government Unit of Talacogon through the BAC Secretariat Office and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be acquired by interested bidders from August 1, 2025 to August 20, 2025 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (Php 25,000.00).

The LGU of Talacogon, through the BAC will hold a Pre-Bid Conference at 10:00 a.m. August 8, 2025, at the PDA Office Municipal Hall, Talacogon, Agusan del Sur, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before August 20, 2025, 10:00 a.m., All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bid Opening shall be at 10:00 a.m. on August 20, 2025 at the PDA Office Municipal Hall, Talacogon, Agusan del Sur. Bids will be opened in the presence of the Bidders representatives who choose to attend at the address below. Late bids shall not be accepted.

The LGU of Talacogon through the BAC reserves the right to reject any and all bids, declare a failure of bidding, or not to award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 at its IRR, without thereby incurring any liability to the affected bidder or bidders.
