The Local Government Unit of Talacogon, through the General Fund FY 2025 had allocated the sum of ONE MILLION, FOUR HUNDRED THIRTY-SIX THOUSAND, FIVE HUNDRED PESOS (Php 1,436,500.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of Milled Rice for the Peace and Order Programs, Projects and Activities (PR NO. 28072517-18). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Local Government Unit of Talacogon, Agusan del Sur now invites bids for the Supply and Delivery of Milled Rice for the Peace and Order Programs, Projects and Activities. Delivery of the Goods is required within ten (10) calendar days. Bidders should have completed a contract similar to the project within five (5) years from the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through an open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

(i) Bidding is restricted to Filipino citizens/sole proprietorships, Cooperatives, Partnerships, or Organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Local Government Unit of Talacogon through the BAC Secretariat Office and inspect the Bidding Documents at the address given below from 8:00 a.m. to 5:00 p.m..

5. A complete set of Bidding Documents may be acquired by interested Bidders from August 1, 2025, to August 20, 2025, from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00)

6. The Local Government Unit of Talacogon, through the BAC, will hold a Pre-Bid Conference at 11:00 a.m., August 8, 2025, at the PDA Office, Municipal Hall, Talacogon, Agusan del Sur, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before August 20, 2025; 11:00 a.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the ITB Clause 18.

Bid opening shall be at 11:00 p.m. on August 20, 2025, at the PDA Office, Municipal Hall, Talacogon, Agusan del Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Local Government Unit of Talacogon, through the BAC reserves the right to reject any and all bids, declare a failure of bidding, or not to award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
