INVITATION TO BID FOR
SUPPLY AND DELIVERY OF ONE (1) UNIT MULTI-PURPOSE VEHICLE TO EXERCISE EXECUTIVE FUNCTIONS

1) The Local Government Unit of Talacogon, through the General Fund FY 2026 intends to apply the sum of Two Million Five Hundred Thousand Pesos (P 2,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for Supply and Delivery of One (1) Unit Multi-Purpose Vehicle to Exercise Executive Functions (Id Number P.R. No. 15012601-01). Bids received in excess of the ABC shall be automatically rejected at bid opening.

2) The Local Government Unit of Talacogon now invites bids for Supply and Delivery of One (1) Unit Multi-Purpose Vehicle to Exercise Executive Functions (Id Number P.R. No. 15012601-01) . Delivery of the Goods is required within fifteen (15) calendar days. Bidders should have completed, at least three (3) years from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3) Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.

i) [Select this paragraph if conditions (a), (c), and (d) under Section 52.4.1.2 of the IRR do not exist:] Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a

country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183. ii) [Select this paragraph if condition (a), (c), or (d) under Section 52.4.1.2 of the IRR exists:] Bidding is open to all interested Bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR.

4) Interested Bidders may obtain further information from Local Government Unit of Talacogon and inspect the Bidding Documents at the address given below from January 26, 2026 to February 16, 2026.

5) A complete set of Bidding Documents may be acquired by interested Bidders on January 26, 2026 from the address given below BAC Office, Municipal Hall, LGU-Talacogon, Agusan del Sur upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos P5,000.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6) The Local Government Unit of Talacogon will hold a Pre-Bid Conference on February 03, 2026 at BAC Office, Municipal Hall, LGU-Talacogon, Agusan del Sur and/or through video conferencing via zoom conference, which shall be open to prospective Bidders.

7) Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through (i) manual submission at the office address indicated below, (ii) online submission through the electronic bidding facility of the PhilGEPS as indicated below, on or before February 16, 2026 10:00 a.m. Late bids shall not be accepted.

8) All Bids must be accompanied by a Bid Security in any of the acceptable forms and in the amount stated in ITB Clause 16.1.

9) Bid opening shall be on February 16, 2026, 10:00 a.m at BAC Office, Municipal Hall, LGU-Talacogon, Agusan del Sur and/or via zoom conference. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
